The Dalit International Organisation has instituted the Dr. Ambedkar International Award to be given every three years to prominent leaders who work for the welfare of the down-trodden people.


Thus the DIO Committee unanimously nominated Mr. K. R. Narayanan

Every human being should detest caste discrimination, he said. Datuk Sabbaruddin Chik who is also the Secretary General of the ruling UMNO (United Malays National Organisation) Party declared open the Convention.

The First World Dalit Convention was held at the Kuala Lumpur Mines Resort City on 10th and 11th October, 1998. The Malaysian Minister was accorded a grand traditional welcome by Malaysian women clad in colourful Malaysian attirements.

The Minister released hundreds of balloons to mark the freedom of Dalits from the bonds of Casteism and slavery.

discrimination. The government is fair to all. It is most unfortunate that discrimination

prevails in Indian community throughout the world. Education is the best cure to this caste disease. One can be exalted to greater heights through education, Datuk Sabbaruddin chik pointed out.

Parents should pay more attention to children's education. They must make sure that their children study well. It is only through education that they can overcome the caste barrier. I was told by Mr. Pandithan that the most famous untouchable leader Dr. Ambedkar struggled very hard to become one of the famous


sons of India and the Father of Indian Constitution.

He had championed the importance of education to stress 'educate, organize and agitate', Datuk Sabbaruddin Chik told the enthusiastic delegates. It is not enough that parents only care for childrens' academic education. Moral education is equally important. Discipline for children is vital, he stress. Sowing the seeds of



dignity at a very young age is also important. They should be proud of themselves so that they will never fell the inferiority complex, the Minister said.

The two day convention held on 10th and 11th October 1998 was well attended by more than 700 delegates throughout the world including famous politicians noted leaders from dalit movement, champions of down-trodden, social reformers, renowned economists, famous educationists and great scholars.

The Malaysian Minister of Tourism, Arts and Culture Datuk Sabbaruddin Chik officially opened the conference which saw the opening very colourful with Malaysian cultural and traditional dances performed by Indians, Malays and Chinese.

Mr. Kanshi Ram garlanded the Portrait of Dr. Babasaheb Ambedkar while Dalit Sena President Ram Vilas Paswan

Dr. Ambedkar could not sustain the going due to the constant pressure of the mighty upper caste Hindus, Mr. Kanshi Ram told the delegates who packed the hall.'Babasaheb Ambedkar was able to get reservation for the oppressed in legislative houses, job opportunities in government departments and also places in higher educational institutions.

I wish to stress upon that

prepare my people to become rulers. If we do not become rulers, our problems will remain forever, Kanshi Ram said.

In order to become rulers we must learn how to handle caste. Dr. Ambedkar, Nehru, Gandhi and Indra Gandhi were experts in handling caste.

is how we could get many benefits from the British, he added.Mr. Kanshi Ram expressed concern for 10 crores slum dwellers who are deprived of proper drinking water and electric supply.

People migrating from villagers to cities are also being denied of many facilities and end up in polluting the environment.But those refugees who came from Pakistan after independence were duly taken care of by the then government and a special budget was allocated to meet their basic necessities, he pointed out to the delegates.

According to Mr. Kanshi Ram, slum dwellers presently living in urban areas are the Dalit refugees who have migrated from villages because of acrimonys and atrocities committed by upper caste Hindus. They have not been able to influence the Planning Commission and the Government of India to allocate separate budget to provide them bread, clothes and shelter.

A decent life is a matter of fundamental right of every citizen in accordance with the constitutional mandate, Mr. Kanhi Ram asserted.

He advocated separate settlement for dalit people as

once formulated by Dr. Babasaheb Ambedkar.

He was very critical of the evil impact of caste-system in India. Whatever the Indians went they never failed to carry with them this spreading disease he told the laughing and cheering crowd.

The Indians are prepared to leave anything behind. They leave behind their little property, small land and their huts. But they will never leave behind their caste. They carry with them whatever they go, he said.

While urging the dalits to unite, he also called upon the Dalit intellectuals to shed away the approach of existing analysis only.

They should instead come with forward looking approach in education, economic and social problems.

They must also come up with some sort of effective solution programme, Mr. Kanshi Ram added.

Mr. Kanshi Ram impressed upon the delegates that Dalit problem can only be solved through political power to rule the country.

"We must become the rulers instead of being ruled," he told the cheering and applauding delegates.

I am prepared to disband the Dalit Sena and forsake the Janata Dal and follow you, Mr. Paswan told Mr. Kanshi Ram at the opening day of the 1st World Dalit Convention in Kuala Lumpur.

Mr. Paswan looked serious while the Bahujan Samaj Party President Mr. Kanshi Ram was virtually shocked but the delegates who had come from many parts of the world rejoiced and gave a thunderous applause for the novel idea. How long are you going to live? He asked Mr. Kanshi Ram. How long am I going to live? Come, let's do something for our people, Mr. Paswan added. The former

Minister was responding to Mr. Kanshi Ram who had just concluded his keynote address at the opening day. Paswan spoke for about an hour touching various points on politics, education economic and social problems of the dalits. Unless we have the RSS type of cadres we will not be able to match and achieve

today, in many parts of the country, dalit people have not even seen ballot papers. Untouchables cannot even rent houses in good localities. The situation is far worse in Ahmedabad (Gujarat) the place where Gandhi was born, Mr. Paswan said. He also spoke on the discriminations shown on dalits when filling senior

bodies for all people but when implemented, they are misinterpreted to deny benefits for lower strata people.

This happens because the courts are monopolized by the upper-caste people and we don't have a Dalit Judge in India.

To check this judiciary imbalance Dalits should be appointed as judges and also

system as a cancer which has no cure. You can change your religion. A poor man can become rich. A man can even become a woman but you cannot change your caste even after your death. You may go away from India to stay in other countries but caste will continue to chase you, he told the laughing crowd. The message is very clear. We have to build our strength. We must also plan our programmes and methods. And Education must be our top priority. Reservation is our constitutional right but others also will not want to surrender their powers and privileges, he told. We may be in different platform and organizations but we must always unite to safeguard dalit welfare whenever threatened. We should try to forgo our ego and differences to find a solution. More conventions in other parts of the world will create awareness and help to build a strong 'Dalit International Organisation,' Mr. Ram Vilas Paswan said in his speech. He had lots of praises for the organizing chairman Mr. M.G. Pandithan for a job well done. At the end of his speech the organizing chairman and IPF President M.G. Pandithan invited Mr. Kanshiram and Mr. Ram Vilas Paswan to the stage and locked their lands to wave to the rejoicing delegates expressing dalit solidarity.

“I am not a BANDID QUEEN”

PHOOLAN DEVI TELLS THE WORLD

“I was not born a bandit. There are no bandits in my family,” says Phoolan Devi.

“It was not born a bandit. There are not bandits in my family,” says Phoolan Devi.

“It was society that turned me into one. Because I was born in a poor family and from a low caste, I was subjected to degradation and dishonor. She told the World Dalit Convention.

“In my backward village in Uttar Pradesh, caste discrimination was practiced to the maximum-between the pure and impure, the touchables and the untouchables.

“We were only allowed to take water from the well later in the day after people from the upper caste had their turn and we were not allowed to bathe upstream,” Phoolan related her terrible and harrowing experience as a member of the Mallah caste, a Shudra sub-caste of boatmen, at the First Dalit World Convention held in Kuala Lumpur, on 10th and 11th October 1998.

The theme of the convention was “A New Vision Towards a Casteless Society.”

In advocating the fight against discrimination towards Indians of the lower caste, Phoolan cited her life story-one in which she suffered unspeakable acts of degradation and humiliation because “it was my destiny.... I was born to serve others.” She told the delegates. I was forced to marry at 11 to a much older man who raped and beat me. I ran away only to find that a woman without a husband “was fit only for abuse.” Even at such a tender age, I knew instinctively

that “a battle was just beginning, and it would be daily, cruel and terrible.”

I survived beatings, verbal abuses, gangrapes and ostracism but ostracism but determined not to take my own life but to go on living.

I did not join a bandit gang, but was kidnapped into one. After her bandit husband Vickram was killed, she survived to lead her own gang and claimed retribution for the wrongs done to her. Phoolan and



her gang of bandits raided villages and robbed the rich to give to the poor. “People of my caste heard all about it. If a mother wanted to protect their daughter, or a father his wife or his sister, they knew all they had to do was say to the rapist that Phoolan Devi would punish them.

“People of my caste heard all about it. If a mother wanted to protect their daughter, or a father his wife or his sister, they knew all they had to do was say to the rapist that Phoolan Devi would punish them.

“That’s why, whenever I heard it, I crushed the serpent that used to torture women. I dismembered them. It was my vengeance,

and the vengeance of all ‘women,” she recalled.

After her surrender to the police in 1983 - so that her family could live in peace - Phoolan was imprisoned without trial for 11 years. In J 994, the charges against her were withdrawn, and she was freed on parole.

Her freedom is provisional, and Phoolan is still waiting for the supreme Court’s final decision for the charges against her to be dropped.



In defending the poor and down-trodden, Phoolan has become a heroine in their eyes. In 1996, amid both popular support and controversy, she was elected to the Indian Parliament. She lost her seat six months ago, but Phoolan claimed that the election was rigged.

“People still know me as a dacoit, a bandit, but that part of my life is over. Which is bad? The crimes done to me or mine against the men that wronged me? She asked the crowd. “Sometimes, you need violence to fight cruelty, but it is a limited way. That is enough. . My personal vengeance is over,” said Phoolan solemnly. My mission now is to make sure that the

degradation I suffered does not happen to others.

“I am not educated in the typical sense, but the lessons I have learnt can never be told in words.

“I visit the villages and speak to the people. I tell them that they must not follow traditions blindly.

“Traditions say that young girls must be married by 11 or 12. I tell them not to marry off their daughters so young. Look at what happened to me,” she



said addressing the convention in Hindi. “Upper-caste men come to the villages and pick young girls from low-caste poor families, and take them to be used as they like,” she continued, stressing the need for change in her community’s mindset.

It is not only women’s fight, she stressed. Men from the lower-caste community too, must unite to fight the oppression they have endured for centuries, and defend their daughters and wives against exploitation.

Phoolan emphasised the importance of education, stressing that each village should have a school and that poor people must not be intimidated away from

being educated “by words or by sticks.”

“Because was uneducated, my knowledge of the world was limited. I thought that the world ended where the fields ended and the sun drowned each night in the river.

“If I had been educated, I would have gone to the courts to fight for the land that was rightfully ours. I would not have gone into the jungle,” said Phoolan.

She believes that her efforts in advocating changes have not been in vain. “In some of the villages I visited, I know that I have convinced them not to fight among themselves, and have learnt to settle their disputes amicably.

“I also tell them not to drink, and warn them against indentured labour. I advise them to ask for daily wages. Don’t work for monthly wages because at the end of the month, the zaminders (landlords) may not pay you. Remain free.”

Phoolan had only visited her village once since she was released from prison because “the Thakurs (from a higher caste than her) refused to allow me in.” Her family has moved to New Delhi where she now lives with her husband. Her weapons are different now, but Phoolan continues to fight against the injustices and tyranny suffered by the poor and downtrodden. Phoolan told the delegates that she was disgusted to see the majority being ruled by the minority. Is it not our own weakness that the minority rules us? She asked.

It is because the Dalits have become puppets to others, she added. Our educated people should go to the villages to explain to them the true situation. We must do something for the downtrodden and the women so that our people are united.

I will continue to fight against caste and injustices she declared. (her speech in Hindi was interpreted by Dr. Deepanker).

Pandithan

Victor or Vanquished?

What compelled the Malaysian Dalits to organize the First World Convention of Dalits in Kuala Lumpur, the capital city of Malaysia, on October 10-11, 1998?

They have been living in Malaysia for hundreds of years. They never thought of holding one such convention in the past.

They had organized several Tamil-conferences but they had they had never thought of organizing a Dalit convention till last year. All these days they were Tamils first and Tamils last.

Now for the first time they have come to identify themselves as "Dalits". Once they were saying, "*Thamilan enru sollada, thalai nillada*" (tell that you are a Tamilian and raise your head high) and now they are saying, "*Dalitenru sollada, thalai nimirthu nillada*" (say that you are a dalit and raise your head high)

They have coined a new slogan, "Dalit means Dignity", in this convention. They have also formed their own political party called the "Indian Progressive Front". Today they proudly say that they are the followers of Baba Saheb Ambedkar. They invited Dada Saheb Kansi Ram to deliver keynote address, Phoolan Devi to light the lamp and Ram Vilas Paswan to give valedictory address.

Dalit International Organisation : This convention was organised to acquire a "new vision to create a casteless society". The need to have a "casteless society" has been there in India for centuries and it has become very intensive after the rise of Babasaheb Ambedkar in the Indian politics.

Malaysian Dalits have their relative's all over India and they keep visiting India very often. Yet, they never bothered about creating a casteless society earlier. The gory killings of

Kilvenmani in the seventies or the recent killings in Pallar-Thevars bloody clashes did not move the Malaysian Dalits to have one conference on 'caste'.

All of a sudden, under the Dalit International Organisation (DIO) they decided to hold a World Convention of Dalits in 1998. Why this sudden change among the Malaysian Dalits? All these developments cannot be the results of external forces outside Malaysia. These are certainly results from the internal developments of Malaysia. What are those developments?

Multi-ethnic Malaysia : Malaysia, being a fast developing country, has got several similarities with India. India is a union of states which were under the British rule till August 15, 1947. Similarly, Malaysia is a federation of states that were under British colonial rule till August 31, 1957. Like India, Malaysia is also a land of multi-religious, multi-lingual and multi-ethnic entities. Malaysia is made up of Malays (50%), Chinese (30%), Indians (10%) and others. The total population of Malaysia is around 20 million. Islam being the official religion, the other religions are Buddhism, Hinduism and Christianity. Bahasa Malay is the official language. The other languages are English, Chinese, Tamil and Iban.

Though Islam and Bahasa Malay are the official religion and official language respectively, the religious rights and the civil freedom of other communities are very much guaranteed by the Malaysian Government.

The only glaring difference between Malaysia and India is that the latter has been ruled by the alien Aryan minorities, while the former has been ruled by the indigenous Malays who are known as Bumiputeras. That is why Malaysia has become one of the fastest growing countries

of the world.

Castle Struggle : Had the Malaysian Dalits been discriminated by the Malays or the Chinese people, they would have either launched a Tamil national movement like that of Tamil Tigers of Eelam or returned to Tamil Nadu long back. These Dalits are being discriminated by their own Tamil brethren! That is why it has become a "caste



struggle", forcing the Dalits to identify themselves as "Dalits" against upper caste Tamils. It is once again proved that Hindus will carry their caste wherever they go.

Tamil mesmerism: The upper caste oppression against Dalits is not a recent development. They have been under subjugation for the past several decades. But all these days they never knew that they were slaves. They were mesmerized as Hindus and Tamils and made to accept their slavery as the natural phenomenon. The developments that made them realize their slavery is an interesting story by itself.

The Indians, who were almost Tamil Dalits, were brought to Malaysia by the British Colonial Government as plantation workers in the middle of nineteenth century. The upper caste Tamils must have gone there much latter to do business. Even today, compared to the upper castes,

Tamil Dalits are economically weak and lowly educated. But all these people, like all other migrants, live in urban areas.

Rise of Pandithan : So long the Dalits accepted their inferior position in relation to the upper castes, there was no problem. The Malaysian Indian Congress (MIC), a party of the Indians, has been under the leadership of upper caste Tamils ever since its formation. Thought Dalits formed the bedrock of MIC, they were never allowed to occupy key positions in it. As Dalits became educated and politically conscious they started asserting their position in society as well as in MIC.

Mr. M. G. Pandithan symbolizes this new trend of assertion. His emergence in the Malaysian politics has brought an awakening among

event brought a great turn in the history of Malaysian Dalits.

Mr. Pandithan started a socio-cultural organization called Malaysian Natpani Mandram to educate his people. He started rousing the Dalit pride and culture through continuous awareness campaigns. Dalits, being 65% of the Indians, started feeling their Bahujan strength. Few days before the 1990 elections, Mr. Pandithan formed "Indian Progressive Front" (IPF), a hundred percent workers party and organized rallies all over Malaysia under the title "*Needhikettu Nedum Payanam*" (Long March to Demand Justice). Consequently, during the elections, more than 46% of Indian votes were cast against the Barisan National



the Dalits. Even today, Dalits are not allowed to enter Hindu temples and intercaste marriages between Dalits and upper caste are being rarely accepted. Whereas Dalits marrying Chinese and Malays are living very happily. Dalit girls committing suicide after their disastrous love affairs with the upper caste boys are on the rise. All these developments made Dalits to understand that the people who discriminate and exploit them are none other than their own Tamil brethren. And they started questioning these age old practices which were considered natural till then.

Long March to Demand Justice : As expected, the upper caste leadership of MIC did not tolerate Dalit identification and assertion within the party and society. Mr. Pandithan, who was an MP, was thrown out of the party in December, 1988. This

Party, which is the ruling party now in coalition with 14 other parties including MIC.

Successful Application of Kansi Ram Formula : What Mr. Pandithan did is , he has only adopted the Kansi Ram Formula to consolidate the Voters. The Dalit leaders who came earlier to Senator Pandithan were '*Chamchas*' (stooges) of the upper castes. Few more chamchas are still serving their upper caste masters in MIC. Mr. Pandithan denounced this '*Chamchagiri*' and pledged to liberate his people from the yoke of upper castes. With nearly 50% Indian votes being consolidated (which is almost 70% of Dalit votes) Mr. Pandithan has become a Senator. If he consolidated all the Dalit votes, MIC will simply collapse and the Dalit '*chamchas*' will have no other way than to join IPF. In the coalition government today, the MIC has got six MP's of whom three are ministers.

Kumisaka tells of 3 million Buraku Peoples Sufferings



K.L. MINES RESORT CITY: The Buraku Liberation and Human Rights Research Institute of Japan came forward to donate 200,000 yen for the welfare of the Dalit International Organisation (DIO). The Organisations President Mr. Shigeyuki Kumisaka donated

under the leadership of Mr. Shigeyuki Kumisaka. Mr. Kumisaka took the opportunity well when his turn came to be one of the speakers on the opening day of the conference. He spoke in Japanese. His speech was translated in English. He explained well about the

contribution of leather goods for tax purpose and serving as petty police officers to put down peasants revolt and execute criminals. This discriminated them against society. In 1868, the Meiji Restoration took place in Japan, transforming the social structure into a modern society. The 'Emancipation Edict'

Suiheisha encouraged Buraku people to develop a movement to eliminate discrimination. When the movement was succeeding in its objectives, the suppression by the government forced them to support World WAR TWO. Japan was defeated in the war which killed the lives of people in

national government to initiate state policies to solve the Buraku problem. In 1965 the government finally released the recommendations produced by the Cabinet. Dowa Policy Council stating that solving the Buraku discrimination is the responsibility of the government. Basing on the recommendations the Law on Special Measures for Dowa Projects was enacted in 1969. A series of new measures brought some benefits in housing projects and scholarships to Buraku people and their children. But the gap remains wide between Buraku people and non-Buraku people in many areas such as enrolment in High Schools, Colleges, Employment etc, he added. Mr. Kumisaka said that the Buraku Liberation was trying to forge solidarity with Korean counterparts Hyongpyongsa who are fighting against discrimination in Korea. We will also forge good relation with all groups including DIO which fights against discrimination, he said. Meanwhile the All India Confederation of SC/ST organizations Chairman Mr. Ram Raj (New Delhi) donated \$ 225.00 (Two hundred twenty five ringgit only) to DIO.



the money to the DIO at the 1st World Convention - 'A new vision towards a casteless society held at the Kuala Lumpur Mines Resort City. DIO Chairman and President of IPF Malaysia M.G. Buraku Liberation League, an organization fighting to eliminate Buraku discrimination and enhance human rights in Japan. We have discrimination against Buraku people in Japan, a form of discrimination based on social status. There are as many as 6000 buraku communities with a population of more than 3 million people. During the feudal era, our predecessors were forced by the ruling class to engage in certain types of labour including the disposal of dead oxen, the

promulgated by the government in 1871 eliminated the category of the lowest class. But the Emancipation Edict' never ended the discrimination even after 300 years, Mr. Kumisaka bemoaned with disgust. 1892 our predecessors started the struggle against Buraku discriminations and funded the 'National Levelers Association (Suihei-sha), with a declaration, 'Let there be warmth in society, let there be light in humanity.'

and they are using caste to capture political power. Caste itself is a 'power' question and 'power' can be destroyed only by 'power'. This is what Babasaheb Ambedkar said and did. This is what Dadasaheb Kanshi Ram is also saying and doing. And this is what Mr. Pandithan is doing today in Malaysia. This is the most successful formula and the surest way to end Brahminism. Bahujan Indians are eager to see the Bahujan Indians of Malaysia becoming powerful enough to dethrone the upper castes from power. **Caste to defeat casteist :** In a country like Malaysia, Dalits with their 6.5% votes (about 1.3 million population) cannot become rulers but they can certainly become reasonably powerful partners in a coalition government. Dalits are not

majority anywhere in the 190 constituencies of Malaysia. But in most of the constituencies they are the decisive voters. The parties which would like to form the government can easily ignore upper castes but they cannot dare so in the case of dalits. Mr. Pandithan knows it very well and he has played his cards very correctly. We cannot create 'casteless society' by destroying the castes. But we can create casteless society by eliminating 'casteism'. "Caste" cannot be eliminated but 'casteism' can be eliminated. "Casteism" is a fascist thought/ ideology that has emanated from caste system. Caste system is a power structure created by the upper castes to have greater



power and privileges over others. Hence, the powerful Brahminical castes have become the upper castes and 'untouchables'. That is why we say 'untouchability' means 'powerlessness'. "Casteism" is the discriminatory attitude and thought of the 'powerful' against the 'powerless'. This casteism can be eliminated by converting the powerless into powerful. This can be achieved by consolidating the victimized

Many delegates submitted their resolutions in writing. After careful and painstaking study the organizing committee incorporated the various important facts into the second resolution without fear or favour.

Both Resolution 1 and Resolution 2 will be sent to UN Secretary General Kofi Annan Indian Prime Minister Atal Vajpayee, Ministers, Chief Ministers of various states and Government Heads of different countries.

RESOLUTION 1

(a) This convention has recognized the initiatives towards full development of dalit community throughout the world but deeply regrets the flagrant violations of Human Rights such as caste discrimination and atrocities committed on dalits in India and other parts of the world. And India being the main culprit, innocent women and children face untold sufferings in their day to day life.

Therefore this convention unanimously resolves to urge the United Nation to immediately appoint 'Special Rapporteurs' to commence investigation into this Human rights violation and also take appropriate measures



to effect the implementation of fundamental 'Human Rights' instrument for dalits in India and other parts of the world.

(b) This convention

also appeals to the United Nation to regard this problem seriously as it affects the lives and future of 300 million dalits throughout India and the world who are facing a fate far worse than South African or American Apartheid.

RESOLUTION 2

(a) This convention takes a serious view on the prevailing situation in India especially in most states where blatant violations of Human Rights and atrocities are day to day affair of dalits especially innocent women and children are persistently being kept under bonded labour to caste Hindu landlords.



(b) Therefore this convention urges the Central and State governments of India to immediately arrest the situation and also

bring to book those culprits who are responsible for the heinous crimes committed on dalit people.

(b) This convention acknowledges that innocent dalits are being constantly harassed and

victimized through criminal proceedings during frequent caste clashes in several parts of India. This convention therefore urges that respective State Governments take appropriate measures and ensure that unbiased police actions and justice and maintained.



(c) This convention also urges the Central and State governments of India to safeguard all the rights provided for in the constitution especially the Reservation Quotas of SC/ST people at all levels including Police, Armed Forces and Judiciary and also immediately fill up all vacant places without any further delay.

(d) This convention urges the Indian government to supervise the strict implementation of the Reservation Rights at Local, State and Federal level including Police and Armed Forces and also give judicial and



punitive powers to the National Commission for welfare of SC/ST communities so that the commission can play a meaningful and effective role.

SOCIAL JUSTICE PAPER: **HUMAN RIGHTS A MOCKERY IN INDIA!**

Govt. not serious In Implementing

'Social Justice/Equality' was a stormy session. Mr. Yogesh Varhade (Canada) who is well recognised all over the world in internationalising the problems of the Dalit community presented a paper on 'Social Justice'.

The session was chaired by Dr. Mohammad Shabbir (Dr. Ambedkar Chair Professor of Law), International Islamic University, Malaysia.

Mr. Varhade highlighted the evil effect of Hindu caste system on Dalit community. He gave statistical information and upto-date data position of atrocities inflicted upon Dalit men, women and children. He touched on sexual offences committed against Dalit women and children.

He gave relevant information on social condition, discrimination and position of jobs in public and private sectors of the Dalit community in India.

He enumerated social welfare legislations meant for ameliorating Dalits conditions, but he pointed out that the desired result could not be achieved due deep rooted prejudices of upper castes and their dominance in all three wings of the Government and the perpetuation of their discriminatory approach coupled with the influences of Brahminical order.

According to him, the denial of social justice is the denial of human rights. whatever provisions

ensure social justice or other rights to improve the status of Dalits are not duly enforced sharing the essence of fairness and honesty.



Mr. Vahade's presentation was followed by heated debate but it was constructive in nature.

Professor Shabbir giving the concluding remark in his capacity as chairman of the session thanked Senator Mr. M.G. Pandithan, the Chairman of the convention for providing an international forum in Kuala Lumpur to discuss ways and means by the world-wide Dalit leaders, Dalit intellectuals, social activists, scholars, thinkers and academicians.

Addressing on remedial measures, he advocated the relevance of Dr. B.R. Ambedkar's philosophy especially in area of education and social justice and urged to actuate them as a solution package.

Opportunity was extended to delegates to express their views on the theme of the convention. Different resolutions were proposed and discussed thoroughly. The convention came out with a meaningful and constructive declaration - known as 'The Kuala Lumpur Declaration'. The organising chairman of the Convention - Senator Mr. M.G. Pandithan gave his heart-touching concluding remarks and thus by valedictory address by Mr. Ram Vilas Paswan, the convention came to an end successfully by echoing the slogan: 'Dalit means dignity and not untouchability' propounded by Senator Mr. M.G. Pandithan, the Chairman of the Convention'. ♦






